Changes to education in Wales

The Welsh Government is implementing a new curriculum for Wales to better prepare students for a rapidly evolving world. This new curriculum emphasises literacy, numeracy, digital competence and bilingual skills. Aiming to develop confident and capable citizens, traditional subjects are now integrated into six areas of learning and experience, fostering interdisciplinary understanding:

- Expressive Arts
- Health and Wellbeing
- Humanities
- Languages, Literacy and Communication
- Mathematics and Numeracy
- Science and Technology

Assessment practices have shifted focus towards individual learner progression, moving away from one-off judgements in favor of continuous, personalised evaluations.

The curriculum is being rolled out gradually, with full implementation expected by 2026.

Senedd's Petitions Committee concludes smartphone ban unwarranted

The Senedd's Petitions Committee has concluded that a nationwide ban on smartphones in Welsh schools is unwarranted. While acknowledging the potential harms, they emphasise that smartphones can also support student welfare and safety.

The committee recommends that the Welsh Government provide clear guidance and a robust framework, empowering individual schools to establish their own mobile phone policies. This approach allows schools to tailor policies to their own unique contexts, balancing the benefits and drawbacks of smartphone use among students.

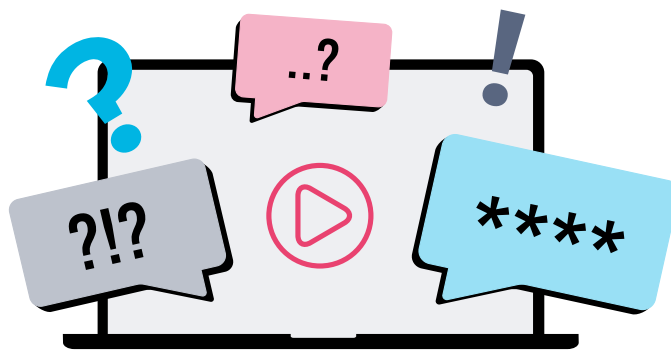
Online safety

NSPCC generative AI

The NSPCC has also published research and recommendations in a report for the government and technology companies. Their research aimed to understand the range of harms that children experience from GenAI, identify solutions to these harms and recommend necessary policy responses.

The report sets out their findings and recommendations, drawn from:

- An analysis of research on GenAI commissioned by the NSPCC and conducted by legal and technology consultancy AWO. The research included two phases of qualitative interviews and a workshop capturing a wide range of professional voices from a variety of sectors such as child safety, GenAI developers and policymakers.
- A consultation with a panel of 11 young people aged 13-16 from the NSPCC's Voice of Online Youth.
- Insights from Childline about children's experiences with AI.

Incels, 'Adolescence' and boys' wellbeing

Staff may be familiar with the recent Netflix series, *Adolescence*. The four-part series shines a light on the dangers of social media and the impact of misogynist influencers on some teenage boys.

Much of the show is set in a school and is reflective of online harms that face children and young people. Guernsey police recently said that the series should act as a 'wake-up call' to parents, carers and professionals who work with children.

When considering outcomes and influences for young boys, the wider context has been reviewed by the Centre for Social Justice (CSJ), and they have published a report looking at key issues facing boys and young men in the UK, and the divergence in boys' and girls' outcomes and attitudes.

The report explores issues around employment, education, families and fathers, crime and technology, including online pornography.

Looking at the increased risk of abuse for d/Deaf and disabled children and young people.

The NSPCC has created the resource pages linked below to inform professionals working with children about the increased risk of abuse for d/Deaf and disabled children and young people.

This includes children who:

- Are d/Deaf
- Have a learning disability
- Have visual impairment
- Have a long-term illness
- Have a physical disability such as cerebral palsy
- Are neurodiverse, such as being on the autistic spectrum or having attention deficit hyperactivity disorder (ADHD).
